Important Information

Nomination of Delegates

The Sub-Branch may nominate any Service of Life member of the Sub-Branch to represent their members at the Annual Conference as the Sub-Branch Delegate [Rule 8.4(a)].

Where no Life or Service members of the Sub-Branch is available to act as a Delegate, an Affiliate member who is either a member of the Sub-Branch Committee or the holder of a Sub-Branch appointment may be appointed the Sub-Branch delegate [Rule 8.4 (b)(2)].

The Sub-Branch must formally advise the Chief Executive Officer of the Branch prior to the Annual Conference if an Affiliate member is to act as a Delegate. This can be noted in the Online Registration Form (details below).

It is important to note that a Sub-Branch Delegate who is an Affiliate member is not permitted to speak or vote on any matter relating to the alteration or amendment of the Rules [Rule 8.4(B)].

Number of Delegates

A Sub-Branch is entitled to appoint one or more Delegates in accordance with the following table [Rule 8.4 (c)].

Number of Life Members, Service Members & Affiliates	Number of Delegates that can be appointed
1 - 80	1
81 - 200	2
201 - 400	3
401 and above (maximum)	4

The number of Delegates will be based on the list of financial Sub-Branch Life, Service and Affiliate members held by the Victorian State Branch as of 30 April 2022.

Directing Delegates

Sub-Branches are reminded that they must hold a General Meeting to direct their delegates in how to vote on motions and remits. This is important as delegates who attend the Annual Conference are doing so on behalf of their Sub-Branch members and must vote in accordance with their wishes. The General Meeting can be held at any time between now and before the Annual Conference.

Registration Details

With this year's State Annual Conference having both in-person and online options, we would ask that Sub-Branches make all efforts to complete the Online Registration Form (see below) with their Delegate(s) details as soon as they can.

Early registration will help to allow sufficient time to 'set up' Delegates and provide specific information and guidance for both attendance options, (eg: training sessions for those attending online; confirming in-person numbers for venue requirements etc...).

All delegates must be registered with the Chief Executive Officer no later than Saturday 2 July, however early registration is appreciated.

In-person details

Online Meeting Platform

For delegates who are unable to attend the conference in-person, we will be using the video and audio-conferencing platform – Microsoft Teams. *Please note - you do not need to have a paid Microsoft Teams account to attend the meeting or to download this application.*

For delegates who will be attending online, we encourage you to download the application early so you can familiarise yourself with the platform. Meeting details and link will be provided prior to the Annual Conference, with guidance on how to join and participate in the meeting.

Online Voting Platform

As delegates will be participating both in-person and online, we will be using a specific online voting platform, to ensure reliable, transparent and live voting information on the day. The voting platform, will be accessible through a normal web browser (eg: Chrome, Firefox etc...) and is mobile friendly.

- For those attending in-person, a mobile device (smartphone/tablet) will be required to cast your vote on the day.
- For those participating online, while you might be using your computer for the Teams Meeting, a separate mobile device (smartphone/tablet) would be beneficial for the voting component. (please ensure you have access to a computer/laptop, smartphone and stable internet connection).

As per previous years, only one (1) registered Delegate per Sub-Branch will be required to log in to the voting platform to cast the required vote on behalf of their members. Each vote will be weighted, ie: if the Sub-Branch has four (4) entitled Delegates, the vote cast will register as four (4) votes in the system. Having only one Delegate authorised to vote on behalf of their members will help minimise accidental differences in voting within one Sub-Branch.

Please indicate on the online registration form which delegate you wish to nominate to be your Sub-Branch's Designated Voting Delegate for this year's Annual Conference.

Further Information

We will be running a 'training session' prior to the Annual State Conference, to help Delegates familiarise themselves with the platforms, and so we can address any queries.
