Construction of a steel roof over an existing outdoor deck area. As well as providing immediate protection from the elements, the additional roof area provides further space for solar panel installation as part of a future project.

#### How urgent are the works?

Are there components that will address dangerous, unusable or inaccessible conditions?

The deck is north facing, exposed to direct sunlight all year round, as well as other climate conditions. The only protection currently is provided by umbrellas. The roof will address this as well as provide additional all year round outdoor dining space which will enhance the amenity as well as complement our Covid-19 protection measures.

To what extent will your project improve the use of the facilities for veterans, their families and quantify the use and benefit (if any) by others and communities organisations.

Additional meeting space will be available to for the 347 veteran members of the Club to socialise as well as veterans in the community who are not members. They along with their family and friends will have greater choice and space available to them, as will other community groups such as Probus, Lions, Rotary and veteran associations that frequent the Club to meet and socialise.

Will the project improve environmental sustainability of the facility? If so, please describe.

We have a desire to install solar panels in the future, more roof space will make that commercially viable. In addition the roof will provide protection from the elements, in particular the sun which at certain times of the year shines directly into part of the bistro.

### Who will benefit from the project?

All who frequent the Club, which on average is approximately 250 people each day. The Club benefits with improved facilities, and veterans and veteran associations as well as various community groups benefit with greater choice and protection from the elements.

## How will the project increase usage of the facility?

The project will allow additional outdoor dining and meeting space. The Club will have the ability to cater for additional groups and patrons, especially our veterans.
