1.3 **Donation Requests.**

1.3.1 Australian War Memorial Last Post Ceremony

In 2019, RSL Vic agreed to support the last post ceremony at the AWM for a period of 3 years with co-contributions coming from Victorian 10a Clubs. Our commitment for 2021 is \$750 paid from our Inc account. With 2020 skipped because of Covid, 2022 will be our final donation under this agreement with RSL Vic to consider any further commitment beyond 2022.

1.3.2 Everyman's Welfare Service

Everyman's Welfare Service are seeking a donation for their Brew Truck upgrade project.

Recommendation: That the Sub-Branch makes a donation of \$500 to the Everman's Welfare Service for their Brew Truck Upgrade project from the Inc account.

1.3.3 Christmas Tree Base

The Committee has previously agreed to display a patch work Xmas tree being constructed by a craft group in the foyer. A framework to support it will be required. It will be built by volunteers but the material consisting of rolled steel and a few nuts and bolts will incur a cost.

Prior to this meeting the Executive met with Ruth Kneebone & Sarah Thompson from the Into Our Hands organisation. They gave a presentation on the structure and operation of their community organisation in particular the GIVE Wangaratta structure.

GIVE Wangaratta is a sub-fund of the Into Our Hands Community Foundation, an independent philanthropic organisation that has been working with local communities across northeast Victoria since 2010. GIVE Wangaratta is a community wide initiative to establish a charitable endowment fund for the long term needs and future of Wangaratta, its people, community groups and local non profits.

There is a possibility that in the future the Sub-Branch could partner with them to the benefit of both organisations.
